

Local 728 Gold Card Information

FOUR STEPS ARE INVOLVED IN THE PROCESS OF RECEIVING A LOCAL 728 “GOLD CARD”.

- 1. A PERSON SHALL BE NOMINATED TO THE COMMITTEE AS A CANDIDATE.**
- 2. THE COMMITTEE SHALL REVIEW THE QUALIFICATIONS OF THE CANDIDATE AND DECIDE IF THEY ARE ELIGIBLE AND WORTHY OF RECEIPT OF SAID CARD. IF DEEMED A QUALIFIED RECIPIENT, THE COMMITTEE WILL RECOMMEND APPROVAL TO THE EXECUTIVE BOARD.**
- 3. THE EXECUTIVE BOARD WILL REVIEW THE FINDINGS OF THE COMMITTEE THEN MAKE A RECOMMENDATION TO THE MEMBERSHIP.**
- 4. THE MEMBERSHIP THEN HAS THE FINAL APPROVAL.**

WHEREAS THE LOCAL 728 “GOLD CARD” IS THE HIGHEST AWARD GIVEN WITHIN OUR ORGANIZATION THE GOLD CARD COMMITTEE RECOMMENDS THE FOLLOWING GUIDELINES AND POINT SYSTEM TO BE UTILIZED IN CONFERRING THIS AWARD.

GUIDELINES FOR 728 GOLD CARD RECIPIENTS

- **AT THE DISCRETION OF THE GOLD CARD COMMITTEE A MAXIMUM OF TWO RECIPIENTS PER YEAR MAY BE RECOMMENDED TO THE EXECUTIVE BOARD AND MEMBERSHIP FOR APPROVAL, PROVIDED THE NOMINEES MEET THE FOLLOWING CRITERIA.**

- **CANDIDATE REQUIREMENTS**
 - **Minimum THIRTY year membership in Local 728.**
 - **Minimum age of SIXTY years.**
 - **Participation in Local 728, i.e.:**
 - **Attendance at Local 728 membership meetings.**
 - **Served as: A Lot Steward
A Delegate to Conventions
An Officer of the Local
An Executive Board Member
A Committee member or Chairperson of Committee
A CLC Delegate**
 - **Service to Industry Charities i.e.:**
 - **Motion Picture Home**
 - **Will Rogers Institute**

- **USE A POINT SYSTEM FOR QUALIFICATION**

- **AT THE TIME OF NOMINEE CONSIDERATION ALL CHARACTER WITNESSES AND LETTERS OF CHARACTER REFERENCES WILL BE ENTERED INTO THE RECORD FOR JUDGEMENT**

- **VIOLATIONS OF THE BASIC AGREEMENT AND OUR CONSTITUTION AND BYLAWS WOULD COUNT AS NEGATIVE POINTS**

3	Membership Meeting Attendance (50% per year or 50% of total years in Local #728)
4	Lot Steward (as this is an appointed position the points for this is awarded one time only, regardless of the number of years served)
4	Executive Board Member (per three year term)
5	Vice-President (per three year term)
6	President (per three year term)
8	Business Agent / Secretary (per three year term)
8	Call Steward / Treasurer (per three year term)

-5	Each guilty verdict found against a person for violation of the Local and International Constitution and Bylaws or Basic Agreement Violations
