



Hello IATSE Local 728 Member,

Thank you for taking the time to consider the Local 728 Scholarship for your dependent's future academic financial needs.

We have changed our policies to make this process more equitable and encouraging to future generations. Scholarship applicants will now be called "dependents" to allow for more of our families to be eligible. Going forward, any member in good standing (even a deceased member who died while in good standing with the local) who is the legal guardian of a student wishing to continue their education after high school can apply. We have also taken out the academic evaluation portion so that more money will go directly to a Local 728 dependent's education.

The Scholarship Fund, in consultation with the Scholarship Committee, has determined this should be a benefit of membership in the local. The range of awards has been replaced with a budgeted amount to be split evenly between all applicants. The Academic achievement will be determined by the secondary educational institution. There will be a minimum award amount each year which will encourage all students to apply. The idea of the Scholarship Fund should be to help students continue to any form of higher learning they choose. From trade school to Ivy League, all prospective students will be helped by this award. The award as always will be given to the institution of higher learning they are accepted at as a full-time student.

We wish your dependents good luck and are happy to help them build a brighter future.

SCHOLARSHIP INFORMATION

Local 728 of the I.A.T.S.E. offers annual scholarships which are open to the dependents of ***members in good standing*** of the International Alliance of Theatrical Stage Employees and Moving Picture Technicians, Artists and Allied Crafts of the United States and Canada (I.A.T.S.E. & M.P.T.A.A.C.) of Local 728.

The rules of eligibility state that the applicant must:

- Be the legal dependent of a Local 728 active member in good standing; or, Be the legal dependent of a Local 728 retiree in good standing; or, Be the legal dependent of a deceased Local 728 member who was a member in good standing at the time of death.
- Make application within the academic year of either high school graduation or attainment of G.E.D. (Institutions may require further certification.)
- Must be a full-time student as defined by the institution student will be attending.
- Have the scholarship award applied to the first year of college or vocational school.
- Use the scholarship award within twenty-four (24) months of the award date.

The procedure for making an application is as follows:

- An application is to be requested from Local 728 and submitted to the Local office with all other documentation by the deadline below.
- A complete sealed copy of the applicant's high school transcript or GED is to be forwarded to the Local 728 office.
- Present at least three (3) letters of recommendation from a teacher, counselors, clergy, community service organizations, employers.
- Submit a photograph with application to be published in *The Bulletin*.

The deadline for filing all required material with the Local 728 Office is April 1, 2022. The winners of each award will be notified by the Local 728 Office in May 2022.
