

Safety Training

One hundred and thirty-one (131) active members to this date have still not finished their safety pass classes. This ranges from missing one class to missing them all. Although I believe that we should not be the policing agent for the AMPTP and the safety pass program, it's becoming more and more difficult to protect active members' jobs – whether they are dispatched from the hall or they get their own work – and they are turned away from the job site when someone in production asks to see their safety passport.

We're getting more and more calls that this is happening, and to be honest with you, there is nothing to ensure that your call gets paid on an 8-hour day because you were sent home. We all have been mandated by the producers and CAL OSHA to take these classes to ensure our roster status in the workforce.

It's happening over and over at the major lots – Warner Bros., Paramount – not on a studio as a whole – but production by production is choosing to check safety passports. If each individual production is checking them now, it will only be a matter of time before it is lot-wide and anyone missing a class will not be able to work at any of the studios.

What I encourage everyone to do is go to the csatf.org web site. Click on Roster General Access on the left hand side. Type in your last and first name, and follow the prompts to Local 728 and see the classes that you have proudly taken, and the classes that you still need.

If by chance you have completed a class or classes – and have the documents to back it up such as your stickers – and the information on the web site does not reflect you attending and passing the course, call me at the local and we will work together to correct the error.

The funny part of it is, these classes should have been completed by August 31, 2004.

And while 131 among us are lacking the required courses, another unfortunate and somewhat humorous side point of this is that we are probably the most compliant of the safety pass program – which lets you know the level of safety on the sets by other crafts working around you.

I am strongly urging everyone who has not completed their courses to high tail it to the training center on Sonora Boulevard or visit the web site and find out the schedule of the classes that are available, and also see what you are missing. That way you can succinctly schedule the shortest amount of time completing your required courses.

Since it's been almost two years since we were supposed to have finished our classes, it appears that more safety pass classes will be mandatory in the near future. So getting the first grouping of the classes out of the way will make certain that you will keep up with the required continuing education.

And while I have your attention, two ballots have come to your door. One is for the special election for the office of president. As you'll read in your official ballot, the nominees are Iain O'Higgins, Ray Poblick, and Larry Freeman. If

Let Us Know

Relationships all rely on communication between the parties, whether business or personal. This also includes your relationship with your Local. Once a month, your Local sends to you this Bulletin to keep you informed about issues and events that are relevant to your work in our industry. In turn, your Local requests that you keep us informed about you.

One of the most important things you can do to keep your Local informed about you is to update your address and phone information. Every month, 20 to 30 Bulletins are returned to the Local as undeliverable. Correct addresses are especially important when elections are held and when a contract ratification vote is held. An incorrect address will leave you out of the voting process. (For those of you that do not know it, we just went through both!) You would not believe the quantity of bad phone numbers the Local has for members who get "on the books." Please let the Local know when you have moved or have new phone numbers.

From time to time, some members have a third party submit a payment, usually by check, for your dues. Unfortunately, too many times there is <u>no</u> information as to who should receive credit for the payment.

If you or someone you know, especially if the check is from a business, is making a dues payment for another member, <u>please</u> be very obvious in noting for whom the payment is to be credited. We do not have a crystal ball that will tell us who gets credit for the check. Post-it notes are unreliable because they fall off or get stuck in the envelopes. The best solution is to fold a piece of paper around the check and write, in BIG letters, for whom the dues payment is

Retiree Profile -

Born to be in the Business

A look at the six-decade career of member Bill Tenny

You could almost say 60-year member Bill Tenny was 'born' to be in the entertainment industry: The native Californian came into this world in a taxi cab in front of the Hollywood Hospital. Moreover, his dad S.D. (Seymour Dean) Tenny, was a member of the Local, and Bill grew up with current Executive Board member Dick McConihay and member Charlie Nippell.

"My dad and Dick's dad walked the picket line together during strikes, we were all friends," Tenny recalled.

But before starting a career in the industry, Tenny felt it was his patriotic duty to join the Navy during World War II. "I enlisted in 1943 and as soon as I graduated from North Hollywood High School, they took me," he noted. Tenny served 22 months between 1944 and 1945. Much of his time was spent on the island of Guam as a Coxswain with the Combat Aircraft Service Unit.

The war ended while he was stationed on the island. Once stateside, he immediately went to work at the studios. "My first job was at Universal. My father worked there making rain on feature productions for 35 years," he proudly added.

"The natural progression was to go into Local 728, but the older guys really didn't want us in. When I started in 1946 there were no benefits. We were permits with a B card. It took about 13 years to get a card in those days, and I finally got my A Card in the late 50's. Actually, Taft-Hartley is the reason why we got our A cards; federal law made the union let us in," he explained.


Tenny found his niche in rigging and held the boss position for roughly 25 years. Some of the notables he worked on included rigging sets for Andy Hardy and Abbott and Costello movies, and the features It's a Mad, Mad, Mad World, Spartacus, Inherit the Wind and The Nuremburg Trial. He added "little pilots and whatever else came around" and an unforgettable three-year stint in Hawaii working on Magnum P.I.

"In those days, there weren't a lot of location shoots and most of the filming was done on the lot. Don Dahlquist and I were the night and day rigging bosses. We had a great time. We use to tease Norm Glasser and Charlie Nippell all the time," he laughed.

Although he isn't sure what year it occurred, Tenny moved to lighting at the studio. While adding pilots to his ever-growing show list, he also worked on memorable features including *Slapshot*, *Smokey and the Bandit*, *The Great Howard Hughes*, *Jaws*, *Sunshine*, *Amber Waves* and the hit television comedy, *Coach*.

Along the way he worked on many Jack Webb shows including the famed Dragnet series. Tenny eventually moved over to CBS Studios and worked on

the pilot for *That 70's* Show, other smaller projects and then finished up his long career on *Third Rock* from the Sun.

With six decades in the business, he naturally had favorite moments and memorable times. "When I worked on Jaws, Spielberg called me 'Candles.' I'm not sure why he called me that, but that was his nickname for me. Everyday at three o'clock, he'd shut down the show and he'd let me tell the crew the progress of the production. I'd

take a bullhorn and tell everyone how things were going. He caught me doing it one time, joking around with some of the guys. And he walked up to me and said. 'I want you to do this every day for us.' I was really doing stuff that I shouldn't have been doing, and it was just funny because it came off the top of my head," he recalled chuckling, adding, "Jaws was supposed to be an eightweek shoot and ended up being six months and terribly over budget. It was an absolute disaster ... but look how it turned out."

One of the most significant highlights came on the production of *Inherit the Wind* in Canada. "It was probably the highlight because I had an all Indian crew. We started at Vancouver Island and went into fishing boats to a bunch of islands and shot at Indian camps. We took all the equipment – generators, everything – in by boat. We even scouted the location by plane with bush pilots. It was probably one of the most exciting films to work on," he said.

Tenny has been married for 57 years to wife George Anne, and the pair raised two daughters. Today, they have two grandsons; one of whom is living with the

to be credited. Your extra effort will be greatly appreciated by the office staff and the member receiving credit may be spared the hassle and fine for working delinquent.

This next point has been presented in these pages many times, but seems to need repeating. Best boys (ACLTs) are required by our Constitution & Bylaws to report new crews and new hires to this office, preferably before they are hired. This includes all features, TV, commercials and music videos, no exceptions.

Most of you working commercials and music videos may feel that, because of the short duration of these projects, it is not necessary to call this information into the Local. This is not true. ACLTs calling in their crews is one of the most reliable ways for the Local to find out who is working delinquent, suspended or dropped and who should be taken "off the books." Believe it or not, we have found suspended and dropped members working on union commercials.

You few lucky ACLTs who go on distant location are required to submit a "Distant Location Report" to the Local weekly. If you find yourself on a distant location without any forms, call the Local and we will fax one to you.

Finally, to all members, remember – if you put yourself "on the books" it is your responsibility to take yourself "off the books."

I could go on and on. Keep in mind that communication is a two-way street. Your Local does its best to communicate with you. The Local can only work for you if you communicate with the Local. Let us know.

Training and Certification Programs are the best offense

Loopholes Can Claim we are 'Unqualified'

We are working on the Training Schedule for this upcoming year and, if all goes well, you will be receiving a mailing in the next few weeks outlining our classes and how to sign up for them. I would like again to emphasize the importance of training as well as how to keep current with upcoming training opportunities.

The workplace is getting more competitive and other organizations are once again eyeing our jurisdiction. We are the experts in Set Lighting and it is we who set the standards throughout the industry. However, since electricity is inherently dangerous, our craft and how we handle electricity has come under the microscope. Particularly in light of proposed OSHA guidelines, it is important that we all take advantage of the training opportunities that are a benefit of membership with Local 728.

Training and Certification Programs are the best offense against those who might exploit loopholes to claim that we are "unqualified." One program that can help protect our jurisdiction is the ESTA/ETCP Entertainment Electrician Certification. This certification is part of the same program that certifies Arena and Theatrical Riggers and several of our brothers and sisters at Local 80 have already taken part in this program. The certification exam will be given at LDI this coming October in Las Vegas. This certification is geared towards the top one-third of Entertainment Electricians and would be a great benefit to any of our Rigging Gaffers or Best Boys.

I will be writing more information about this in future columns and mailings.

On a different topic, many training opportunities occur with little or no notice. When such events happen, I will post the information on the Training Update notification-only email list, at the Local Office and fax a copy to the Lot Stewards.
