In these stressful times, with the holidays upon us, Wall Street falling apart, the SAG situation growing, and the industry facing an uncertain future, we seem to have lost the meaning of union brother and sisterhood.

I've been getting a lot of calls and have been going to many disciplinary hearings regarding our members. Now normally, these types of calls come at the back end of a television show where everyone is exhausted from lengthy shooting days and having to be 'on top of your game' all day long. Unfortunately this season, member-to-

Many complaints are coming from the companies themselves where there is either some disciplinary action taken or the members involved have been given notification. But more and more have come from members calling me directly.

member conflicts are occurring earlier.

I'm not suggesting that we all have to like each other; I'm just suggesting that we all have to work together. By taking a few extra minutes to compose ourselves or to help a brother or sister from taking a situation too far, we could alleviate career-injury situations. It may seem easier to let someone else inform me on how one of our own members messed up, but it's a true sign of union brother and sisterhood when we can take a leadership role and help correct the situation so that there can be a win-win outcome. This isn't just the say 'hi'

in the morning and 'bye' in the evening and give a group hug on Friday. This is about true communication between crew members. We need to be open enough to educate ourselves to see a situation that could quickly escalate and be professional enough to skilfully redirect energies into a more positive, creative outcome.

Additionally, it is critical that all members exercise their Weingarten Rights. If you are called into a meeting where where you believe disciplinary action may take place, you have the right to union representation or to respectfully decline until a union representative is present.

As I started off, everyone has issues on and off the set, and without a doubt these are some trying times. However, member-to-member fighting looks bad for our industry, it is a terrible mark on our profession, gives the Local a bad name and makes the individuals involved look unprofessional.

It is far better all the way around if you find yourself in this situation that I get the call from you rather than from the company. My door is always open and my phone is always on. If you can't solve the dispute between yourselves, I highly urge you to contact me immediately to help resolve the issue.



# LDI 2008

¬he LDI Trade Show & L Convention was held October 21 - 26 at the Las Vegas Convention Center. LDI is the international event that deals specifically with all aspects of Entertainment Lighting. From portable power distribution equipment through the latest advances in LED technology, this is where all of the players in the industry get together and show their gear. Many of our old friends like Mole, Arri, ETC, AC Power Distribution, Bender, & PRG participate as do many new supporters such as Baxter Controls, Doug Fleenor Designs, Coolux, Martin, Nemetscheck(Vectorworks), and ESP Vision.

As in years past, Local 728 hosted a booth on the trade show floor where both vendors and attendees could come and see firsthand the skills and talents of our members. The booth design was simple and effective with most of the booth materials being donated by PRG. ETC graciously provided us with three Source 4 Jrs, and our banners

were printed by the Warner Brothers Sign Shop.

The centerpiece of the booth was a large flat screen monitor displaying a slide show of our members and several large and impressive rigs. This trade show draws visitors from all over the world, but most notably, Local 728's Booth was visited by representatives of 32 other IATSE Locals from the United States and Canada.

In addition to the booth, Local 728 hosted two presentations that showcased the work of our members. These sessions were extremely well received and attended. The first panel, Advanced Lighting Technology in Motion Pictures was held on Saturday morning and we had approximately 35 people attend. Brothers Joshua Thatcher and Scott Barnes were featured on the panel with lighting designers Lee Rose (Local 600); John Tedesco, Jeff Ravitz and media server developer Steve Gilbard. I mediated the panel and several Local 728 members attended. The conversation centered around the

current and future usage of media servers, digital lighting, and automated lighting on our stages and sets.

Michael Lay of Strand Lighting. Brother Tony Ward spoke on his work on the Special Olympics in Shanghai and the Democratic National Convention in Denver. Joshua Thatcher and Scott Barnes spoke on the development of networking in our industry and discussed their work on GI Joe and Angels & Demons.

One highlight of LDI 2008 was the recognition given to Local 728 member Phil Berardi. He won the *ESTA 2008 Members Choice Product Award* for his Firefly LED Cable Protector. This is his second award for this ingenious product. In June, he took home the Rave Best of InfoComm 2008 "Most Creative New Product" award.

There are three areas where our participation in LDI directly benefits the members of Local 728. The first is direct involvement with the companies that make the equipment and materials that we use everyday. Our involvement with LDI has created relationships with these

### 11th Annual Local 728 Scholarship Awards

Your Local 728 officers and members are pleased to offer 10 scholarship awards.

Five awards in the amount of \$4,000.00

and five awards in the amount of \$2,000.00 for the academic year 2009.

The 11th annual awards will be granted to high school students graduating in 2009.

### WHO IS ELIGIBLE?

The rules of eligibility for the 11th Annual Local 728 Scholarship Awards state that an applicant must:

- a) Be the son/daughter of a member in good standing of Local 728.
- b) Be a high school senior at the time of application.
- c) Have applied, or be about to apply for admission to an accredited college or university as a fully matriculated student.
- d) Have applied, or be about to apply for admission to a vocational school.
- e) Use the scholarship award by the first term of the same year awarded.

### **HOWTOAPPLY?**

- 1. An application is to be requested by completing the coupon below and forwarding same to Local 728 at the address below.
- 2. The application is then to be completed and returned to Local 728.
- 3. A complete sealed copy of the applicant's high school transcript is also to be submitted to Local 728.
- 4. The record of scores achieved by the applicant on the Scholastic Aptitude Test, college entrance examination, or other equivalent examination may also be submitted, either by the student or by the testing organization.
- 5. At least three (3) letters of recommendation should be submitted for inclusion in an applicant's file and will be accepted from any of the following: Teachers, Counselors, Clergy, Community Service Organizations, Employers, etc.
- 6. In addition each applicant will be required to have a personal interview with the selection committee.

### **DEADLINE?**

The deadline for filing all of the above required materials with Local 728 is DECEMBER 31, 2008. The winners of the scholarship awards will be notified by Local 728 in May 2009, and will be announced in a future issue of the *Local 728 Bulletin*.


