

55th Annual Scholarship Awards-Walsh/Di Tolla/Spivak Foundation

Applications for the Richard F. Walsh/Alfred W. Di Tolla/Harold P. Spivak Foundation 55th Annual Scholarship Awards are now available. Each winner of the TEN scholarships will receive a total of \$10,000 in scholarship funds which will be paid out at \$2,500 per year directly to the recipient's educational institution over a four-year period. Counting the 2024 awards, the Foundation will have had 130 scholarship recipients to date.

To be considered for the scholarship, you must mail in a completed application form, along with the required documents that can be found here: **iatse.net/scholarship/.**

The deadline for mailing your completed application is December 31, 2024.



IATSE Local 728 Hardship Fund

At our recent November Membership Meeting, changes to our new Local 728 Hardship Fund Loan program were announced. Now to qualify for an interest free loan of up to \$2,500.00, a member needs only to show that they have had \$9,000.00 or less in gross income from covered work in the industry in the past 90 days.

Mental Health for Members

MPTF has identified a therapy practice that is in-network for MPI Active Plan and Retiree Plan participants. This practice has over 300 credentialed providers, has cultural competence in serving entertainment industry members, and has much greater availability than UCLA Behavioral Health Associates and many other providers listed on the MPI "Live and Work Well" portal. Members can reach out directly via https://silverlakepsychology.com/. However, MPTF is happy to facilitate this referral as well, as we assess mental health upon every contact.

New Provider Alert-Alliance Wellness Care

Barriers to access for in-network psychiatrists continue to be significant; the wait time for a UCLA Behavioral Health Associates psychiatrist is several months.
